Review of Auditing Services Proposals

Mr. MacLaren noted that at the direction of the Auditor Selection Committee District staff ran an RFP requesting proposals.

THIRD ORDER OF BUSINESS Ranking of Auditing Proposals

Mr. MacLaren found that McDirmit Davis, who submitted the lowest price of \$12,000.00 for the three years combined, was qualified and so they were ranked the highest. They were almost \$2,000.00 lower than the next lowest bid and have provided auditing services to

more than 50 community development districts. Mr. MacLaren noted that the Board is free to adopt its own rankings.

On MOTION by Ms. Schwenk, seconded by Mr. Adams, with all in favor, the Committee accepted the District Manager's Rankings.

Board Members asked who completed the audit the previous year. Mr. MacLaren responded that the District did not think it would have to have an audit completed for Fiscal Year 2013-2014 but had received a letter from the State stating that the District needs to have one completed. Mr. MacLaren noted that the threshold is \$50,000.00 but the District ended up having \$55,000.00 in expenditures. Mr. MacLaren recommended the Board's authorization for Staff to negotiate with McDirmit Davis to provide auditing services for the fiscal year 2013-2014 for a small fee.

On MOTION by Mr. Adams, seconded by Mr. Heath, with all in favor, the Committee authorized Staff to Negotiate with McDirmit Davis to Provide Auditing Services for Fiscal Year 2013-2014.
