Mr. Amaden opened the bid packages and noted that the bid for Watson Civil totaled \$3,649,538.08, the bid for Tucker Paving totaled \$2,308,885.53, and the bid for South End Civil totaled \$3,195,000.00. The Board will analyze the bids. Mr. Amaden will prepare a bid comparison for the Board to discuss at the next meeting. Mr. Amaden noted that he believes that the District will receive more bids for the Phase 4A construction services. The Board will be opening those bids on October 21, 2015. Ms. Warren asked the Board to confirm that the consideration of these three bids will take place at the October 21st meeting. The Board confirmed. Ms. Warren asked Ms. Gaarlandt confirmed that it was. Ms. Warren recommended that Mr. Amaden review the bids and that the Board come back to discuss them at the next meeting.
